Action taken report of the Institution on Feedback report

1. Feedback form most of the students and stakeholders suggested for the need of more teachers in some specific departments. College authority appointed contractual teachers in many departments against the vacant post. Further some new faculties are appointed recently.
2. The post of librarian has been lying vacant due to superannuation and necessary steps has been taken for appointment for new one.
3. To enhance the facilities in the laboratory, College authority purchase and procure sufficient laboratory equipment's under RUSA schemes for enriching the laboratory facilities in the college.
4. To enhance the facilities in Boys and Girls Common room after discussion with Governing Body, Lumding College (Resolution No. 05, 06, 08 and 09, dated. 05.08.2018 and Resolution No. (Misc.) 01, dated. 24.07.2020) steps are taken for renovation and supply of facilities in Boys and Girls Common room, canteen, laboratories.
5. The College authority has started construction of new building under RUSA scheme wherein there are adequate provisions for the specious classroom, gymnasium and seminar halls.
6. Renovation of College office, departments and Class room is started and be completed from the RUSA fund.
7. College authority undertakes a strategic plan for establishing ICT enabled Class room in near future.
