MEMORANDUM OF UNDERSTANDING

MANSURIYA KUNG-FU INTERNATIONAL SCHOOL, LUMDING, ASSAM

FOR

SELF-DEFENSE & PHYSICAL FITNESS TRAINING

This memorandum of Understanding (herein after referred to as MoU) is entered into on 23.03.2022 between Lumding College, Lumding, Assam herein referred to as LC located at Lumding, Hojai, Assam-782447 and Mansuriya Kung-Fu International School, Lumding, Assam, (Affiliated with Mitsuya-Ha Shito-Ryu Karate-Do Association of India) herein referred to as MKFIS located at Lumding, Hojai, Assam-782447.

The scope of the MoU, the roles and responsibilities of the parties of the MoU are given below:

ALLIANCE OBJECTIVE:

This document outlines a strategic understanding between LC and MKFIS with the primary aim to improve physical, mental health, develop and improve self-awareness, and help heal

from the mental effects of the outgoing pandemic of the participants. The MoU allows the partnering institutions to engage in mutually agreed activities/ services.

NOW THIS MoU WITNESSETH AS FOLLOWS:

DEFINITIONS AS USED IN THIS MOU:

“MoU” means this instrument executed by LC and MKFIS and subsequent amendments issued to the MoU by mutual consent as provided herein.

“Training” means any mutually agreed activities/services organised under the scope of this MoU.

“Cost” means the training cost per student/ month or cost of any services offered by the party involved.

“Duration” means the training duration.

“Examination” means practical examination if any to evaluate the participants in the programme.

AREAS OF COLLABORATION:

MKFIS will provide the necessary training/activity/service requested by the LC at the college Premises and also to the MKFIS Premises when students of LC enrolled in the MKFIS. The training/activity/service requested will be provided by experienced professionals of renown and to help train future trainers and experts.

MONITORING OF TRAINING/ACTIVITY/SERVICE:

IQAC, LC and head of MKFIS will monitor the various aspects of MoU.

GENERAL TERMS AND CONDITIONS:

Week long “Self Defense & Physical Fitness Camp” will be offered annually to LC to its interested students enrolled in the college. Only girl’s students of LC on production of valid identity card may enroll in MKFIS directly and will get full fee subsidy for undertaking Self Defense/Martial Art programme. The general responsibilities for both the parties in this agreement document is detailed below:

1. This MoU will be in effect for five years (5) years from the date of signing unless terminated by either party as per clause 2. Upon the end of the five (5) years since the date of signing of the MoU, the MoU can be renewed for periods of five (5) years thereafter.
2. The MoU may be terminated by either party through a notice of one month. Either party may terminate this MoU if either of the parties is dissatisfied by reasons beyond its

control from going ahead with the implementation of the provisions of this MoU. There shall be no liability on the party to the other arising from the termination of this MoU.

3. Both parties will be bound by and adhere to mutually agreed upon Terms and Conditions.
4. This MoU supersedes all proposals or other prior representations or communications, either oral or written.
5. Appropriate remuneration may be paid to parties engaged in carrying out mutually agreed services at the rates accepted by the parties.
6. The syllabus, fees and other terms and conditions for each programme will be discussed among the parties and enclosed to the MoU before the commencement of the intended programme. The Course will be held in the premises of the LC and LC will provide a space that can accommodate the enrolled number of students. After successful completion of the course, a course certificate will be provided by the MKFIS in association with LC.
7. Electronic/video recording of the course by any individual is strictly prohibited. Distribution of the course booklet in any form to unauthorized personnel is also strictly prohibited.
